July 2020 Constitutional Policing Plan Briefing Inspection Report

The Bureau of Internal Oversight's (BIO) Audits and Inspections Unit (AIU) conducted a one-time inspection of briefing notes for the Constitutional Policing Plan (CPP) to ensure that CPP Roll Call briefings are being conducted. The purpose of the inspection is to ensure compliance with Office policies and to promote proper supervision. To achieve this, a random sample of Sworn employees and reserve employees was chosen by the AIU inspector. To ensure consistent inspections, the *Constitutional Policing Plan Briefing Inspection Matrix* developed by the AIU will be utilized.

### **Compliance Objectives:**

The compliance objectives for this inspection are contained within each of the included tables.

#### Criteria:

- MCSO Administrative Broadcast Number 20-54
- Paragraph 70 of the First Supplemental Court Order

#### **Conditions:**


Administrative Broadcast 20-54 requires that all supervisors who supervise sworn personnel engage in a discussion based on the selected Implicit Bias Roll Call Briefing video. The supervisors are required to complete an associated Blue Team Briefing Note regarding their discussion with their sworn subordinates no later than August 3, 2020.

A random sample that consisted of <u>75</u> total law enforcement employees was obtained by AIU. The sample contained <u>60</u> Sworn personnel and <u>15</u> Reserve personnel. This inspection will be based on the requirement outlined in Administrative Broadcast 20-54 in support of paragraph 70 of the first supplemental court order. The inspection found that <u>78.67%</u> of inspected employees were in compliance with the MCSO Administrative Broadcast Number 20-54.


